

COLON FREE ZONE (CFZ) FACTS

- Established in 1948
- The largest in the Americas and the second largest Free Trade Zone in the world
- ~1,000 acres in surface area (4 million m²) [10% designated as industrial zone]
- Receives over 250,000 foreign visitors yearly
- Contributes about 8% to GDP
- Administered as an autonomous institution of the Panamanian government
- Operated and managed by its Board of Directors, and Executive Committee and the General Manager of the institution



GROSS DOMESTIC PRODUCT




Strong year-to-year growth clearly visible over the last 9 years

ADVANTAGE: GEOGRAPHICAL POSITION

- The location of Panama is ideal to forward goods to the Central American, Caribbean, and South American regions
- High freight traffic due to Canal reduces shipping rates immensely



ADVANTAGE: TRANSPORTATION CONNECTIONS

 The presence of four main ports at both ends of the Panama Canal, a modern airport and surface transportation to Central America —all with excellent frequencies and international connections— allow orders to be shipped quickly to their destination



PORTS ON THE ATLANTIC OCEAN






MIT, CCT AND COLON FREE ZONE






MANZANILLO INTERNATIONAL TERMINAL (MIT)






COLON CONTAINER TERMINAL

ADVANTAGE: CONSOLIDATION/DECONSOLIDATION

 The establishment of a warehouse in the CFZ allows reception of goods from various sources and filling orders made by a single buyer under one invoice



ADVANTAGE: EXPRESS IMPORT AND EXPORT PROC.

- The documentation required for the entry and exit of goods is simple and expeditious
- Merchandise that transits through the CFZ is not subject to import and export taxes



ADVANTAGE: PROVEN EXPERIENCE

 Branches and multinational firms as well as local companies have provided warehousing and forwarding on behalf of foreign corporations in this zone as early as the late 1950s



ADVANTAGE: CAPITAL FLOW

 The movement of funds in and out of Panama is not restricted, and it occurs mainly in US Dollars, currency of legal exchange in the Republic of Panama



ADVANTAGE: FISCAL INCENTIVES

 The net earnings on the re-export operations are exempt from income tax, as well as the dividends declared on such earnings



HOW TO BECOME ESTABLISHED IN THE FREE ZONE

Any company or person of any nationality that wishes to become established in the Colon Free Zone can do so under one or more of the following operational schemes:

- Land Rental Contract
 - The Colón Free Zone rents land to local foreign companies, to build warehouses and offices for their own use or for a third party
- Building or Commercial Rental Contract
 - Private warehouses can be rented after Free Zone Administration's approval
- Contract whereby a company is represented by another
 - Colón Free Zone law allows that an established company in the Colón Free Zone may represent another
- Colón Free Zone Public Warehouse Contract
 - This option will allow you to use the Free Zone's public warehouse to store your inventory

THE EASIEST AND SIMPLEST WAY

We recommend that you establish your company as a represented company. FCI Logistics can serve as your representative.

The advantages for your company are:

- No need to hire and keep workers of your own
- No need to purchase, rent or acquire property for office and warehouse
- No need to pay monthly fees to the Free Zone (security, garbage service, land rental costs)
- No need to report all commercial transactions to the Administration of the Colón Free Zone; these transactions are reported by the company representing you
- No import duties paid on the cargo that comes in and is then exported
- 0% tax on income



SALES OPERATIONS PERMISSIBLE IN THE CFZ

- Re-export of goods from CFZ warehouses
- Sales to clients located within Panama's Customs territory
- Direct sales to foreign customers in which goods are shipped from a third-country manufacturer without physically arriving in the CFZ
- Transfers in which sales are made to other CFZ firms

Acceptance of a Representation Contract

Both parties (Representative and Represented) must sign a representation agreement

Legal Tax Declaration By Legal Representative

 Declaring that the Represented company and the legal representative are not involved in illicit activities
